7.2 INFORMATIONAL ITEM: \$250.00 Appearance Requirement in the SBA Funding Policy (Jacqueline Logan)

- Funding policy indicates that you must appear if you request more than \$250.00 and optional appearance under \$250.00
- No language regarding whether or not appearance is required when a request is for exactly \$250.00

- Jared Christensen suggests that we interrupt the policy as meaning that any request that is \$250.00 or below is optional appearance
 - O This way funding at 50% is at \$125.00 instead of some amount involving change
 - o General consensus agrees

- SBA Representatives should begin to collect the opinions of students regarding current uses and preferred uses of the gazebo

 - o Having a thorough foundational understanding of what students want will help to legitimize any future proposal
- Jared Christensen comments that the funds for the projects are not allocated specifically for a gazebo project but if we can collect valuable feedback and information from students about what they are interested in we can get a better idea of what funds may be needed to accomplish a gazebo renovation
- Feedback should be brought forward by October 30th, 2013
