7.2 ACTION ITEM: Barrister's Ball Committee (Committee Chairs)

- o Committee co-chairs apologize for confusion of "comping" tickets
- Did not understand that "comping" was a percent that had been followed from past years because SBA members are expected to attend SBA funded events
- O Committee co-chairs indicated that the money normally used to "comp" tickets was used for décor, food, drinks, etc
- O Committee co-chairs also report that attendance is up but that there is a significant issue with 1L participation
- O Some concern that 1L students aren't aware of what an upscale event Barristers is and so do not find the \$70.00 ticket price reasonable
- O Mirwais Haider explains that the less students that attend the more money the budget will have to reimburse tickets that didn't get "comped"
 - O Selena Farnesi is concerned that working towards "comped" tickets is counter productive since the SBA's goal should be to max out attendance so that as many students are as involved and get to participate as possible
- O Currently at 280 students, space reserved 370, with 1 week to go
 - O Jared Christensen suggests increased advertising, especially to 1Ls, is important in the last week of ticket sales
 - Currently advertising on the docket, and Facebook, and with physical posters
 - o Committee has been presenting in 1L classrooms
 - o Christopher Wu suggests that we should do some sort of promotional event during the lunch hour
- O Christopher Wu clarifies that food is \$45.00 per person and drinks are \$35.00
- O Lexi Howard suggests that a selling point should be that your \$70.00 ticket is worth a \$120.00 plus value
- o NO ACTION TAKEN

- O Mario Walther sent e-mail to the 1L class asking or interested parties to respond with a letter of intent and a resume
