6.3 INFORMATIONAL ITEM: Bylaw Posting (Mario Walther)

- o Michelle Scheinman resigned because bylaws weren't posted today by 8:00am

 - Delayed because we had to keep having extra meetings to have more discussion
- O Selena Farnesi makes several suggestions for the Board's consideration
 - 1. Amendments can be posted online for student review WITHOUT supplemental materials immediately
 - 2. Amendments can be posted online for students review WITH supplement materials as soon as they are prepared, and a disclaimer that the materials have not be reviewed or approved by the current SBA Board
 - 3. Amendments will not be posted until after Monday's meeting when supplemental materials can be reviewed and approved and all documents can be posted together
- Monika Troike doesn't want to post amendments without notes/minutes
- o Board discusses how to proceed with policy review
- Selena Farnesi suggests that the Election Code, Election Committee, Funding policies, and Transparency policies are most important
 - o Mirwais Haider doesn't want anything to be discussed

- Mario Walther asks if anyone has a different order of importance
- Lexi Howard suggests putting the most pertinent policies on next Monday's agenda
- o Stephen Guichard suggests making amendments in advance per written feedback
 - Jacqueline Logan agrees and suggests limiting discussion next meeting to comments on amendments only
